P. V. Narsimha Rao Telangana Veterinary University, Hyderabad, a premier University offering high-quality education in veterinary sciences in the state of Telangana was established in 2014. It has a rich history tracing its roots back to Osmania University and Andhra Pradesh Agricultural University. The college of veterinary science at Hyderabad, the oldest constituent college of the university was established in 1946. The university offers undergraduate, postgraduate and doctoral programs in veterinary and allied sciences.

This university is recognized globally and many graduates have secured admissions into prestigious institutes worldwide for further studies. Students from this university are also practicing as Vets in various countries after passing the required licensing exams. The university's strong foundation in veterinary education and research provides the students with the opportunity to work on the latest developments in veterinary sciences and prepares them for global careers. Many graduates from this university have secured placements in top organizations, leveraging the university's strong reputation and industry connections. Some of the graduates were selected for the most prestigious civil services in India. Various career paths offer veterinarians to make a meaningful impact on animal health, welfare and public health.

With a view to encourage Non-Resident Indians (NRIs) who wish to pursue higher education in their motherland, the university has started offering Bachelor of Veterinary Science and Animal Husbandry (B.V.Sc. & A.H) for NRIs from the academic year 2024-25. Studying in India can provide NRIs with a chance to reconnect with their heritage and contribute to India's growth.

This university also started self-finance quota seats for students aspiring to become veterinarians, but could not secure merit based admission, on payment of higher fees.

Bachelor of Veterinary Science and Animal Husbandry (B.V.Sc & A.H) is a five and half year degree program designed as per Veterinary Council of India (VCI) curriculum and covers various aspects (basic veterinary sciences, clinical, para-clinical and livestock production) of veterinary science.

## NRI Quota includes

- **Non-Resident Indian (NRI):** In case of general public, an individual who is an Indian citizen or person of Indian origin is said to be NRI in any financial year, if the candidate satisfies the following conditions:
  - A candidate resides in India for less than 182 days during previous financial year (OR) who stays outside India for employment or for carrying on business or for any other purpose indicating his intention to stay outside for an uncertain period.
  - An Indian citizen who stays in India for less than 365 days during the four preceding financial years and less than 60 days in that financial year.
- **NRI Students:** Non-Resident Indian (NRI) students are Indian Nationals who studied abroad. They must have had at least three years of education in any foreign country during the last 6 years and must have passed the qualifying examination (12<sup>th</sup> standard or equivalent) from recognized colleges or institutes located abroad. The parents of NRI students shall have annual income sufficient to support the course of study of their ward.
- **Overseas Citizen of India (OCI)/ Person of Indian Origin (PIO) :**  
The OCI Card holder (including a PIO cardholder) is a foreign national holding a passport of a foreign country and he is not a citizen of India.
- **NRI Sponsored candidates** will be considered subject to the fulfillment of the following:

The sponsor shall be related to the applicant i.e., father, mother, brother or their children, sister or their children, maternal uncle or his children, maternal aunt or her children, paternal uncle or his children, paternal aunt or her children, maternal grandfather, maternal grandmother, paternal grandfather and paternal grandmother. The sponsor must produce proof of an annual income sufficient to support the course of the study of his/her ward.

## Eligibility

Applicant under **NRI/NRI sponsored category** must belong to one of these categories: 1) Non-Resident Indians 2) NRI Students 3) OCI/ PIO card holders and 4) NRI sponsored candidates.

Applicant under **Self finance category** shall be citizen of India, who has completed primary and secondary education in India.

## Academic qualifications

The applicant must have passed and secured a minimum of 50% aggregate in the 12<sup>th</sup> standard (English Medium) from an Indian Board or an equivalent Board outside the country with the subjects of Biology (Botany and Zoology) and Physical Sciences (Chemistry and Physics) for admission into B.V.Sc. & A.H.

## Age limit

The candidate should have completed 17 years on 31<sup>st</sup> December, 2025.

## Application fee

Applicant has to pay non-refundable application fee of Rs. 10,000 (Rupees ten thousand only)

## Criteria for selection

The selection of candidates shall be based on the rank obtained in the NEET (UG) - 2025. In the absence of NEET qualified candidates, TG-EAPCET qualified candidates will be considered.

## Rules of Reservation

Rule of reservation as per Govt. of Telangana shall be implemented for self-finance quota seats only.

- For each extended year of study, an additional fee of Rs.10,00,000/- per annum will be charged.
- Once paid, the fee shall not be returned under any circumstances.
- All the legal issues shall be settled under the jurisdiction of Hyderabad only.

### **General Information**

- Candidates suffering from certain disabilities, as specified in the Minimum Standards of Veterinary Education Regulations, 2016 of the Veterinary Council of India ([www.vci.dahd.gov.in](http://www.vci.dahd.gov.in)), are not eligible for admission.

- **Hostel facility:** Hostel facility shall be provided subject to availability of accommodation in the respective colleges. Interested candidates may apply to the Chief Warden of the respective college for hostel accommodation. They must pay the prescribed fee according to hostel rules. There is no separate hostel for students admitted under the NRI/Self-finance quota. The hostel mess is run on a dividend system for all students.
- All admissions shall be deemed as provisional and subject to further scrutiny. They shall be liable to cancellation at any stage during the study if it is found that an admission is contrary to the rules or invalid by reason of incorrect or false information furnished by the applicants or their parents/guardians at the time of admission. Any cancellation of admission shall not exclude penal action under relevant criminal law.
- RAGGING IS PUNISHABLE AS PER PROCEEDINGS OF HON'BLE SUPREME COURT OF INDIA IN SLP (C) NO. 24295/2004 CONVEYED BY THE UNIVERSITY GRANTS COMMISSION VIDE LETTER NO.F.1-8/2006 (CPP-II) DATED: 04.03.2008. If any incident of ragging comes to the notice of the authority, the student concerned shall be given the liberty to explain and if his/her explanation is not found satisfactory, the authority would expel him/her from the institution.
- All candidates admitted under these categories should abide by the Academic Rules and Regulations prescribed in the Act, Statutes, Regulations and Rules of the University, which may be subject to revision from time to time.

### **Instructions to the candidates:**

- Candidates admitted under these quotas are not eligible for any reimbursement of fee or any other educational concessions offered by the Government.
- Furnishing any false information in the application will result the cancellation of admission at any stage.
- All the rules and regulations governing B.V.Sc. & A.H. program of this University will apply to the candidates selected under NRI/Self finance quota also.

- Candidates will have to attend physically for certificate verification at their own cost on the day of counseling.
- The applicant is informed that mere submission of the application and attendance at certificate verification do not automatically guarantee a seat.
- University does not guarantee any employment to the candidates.
- This University (PVNRTVU) is the only Veterinary University in the state. The University has not accorded affiliation to any private colleges in Telangana State.

- Parents and students are informed that admissions are purely based on merit and guidelines of the university and as such they are requested not to rely on any middlemen/persons/consultants who try to mislead the students in securing admission into PVNRTVU under any quota. All seats will be filled by the university through counseling in physical mode only.

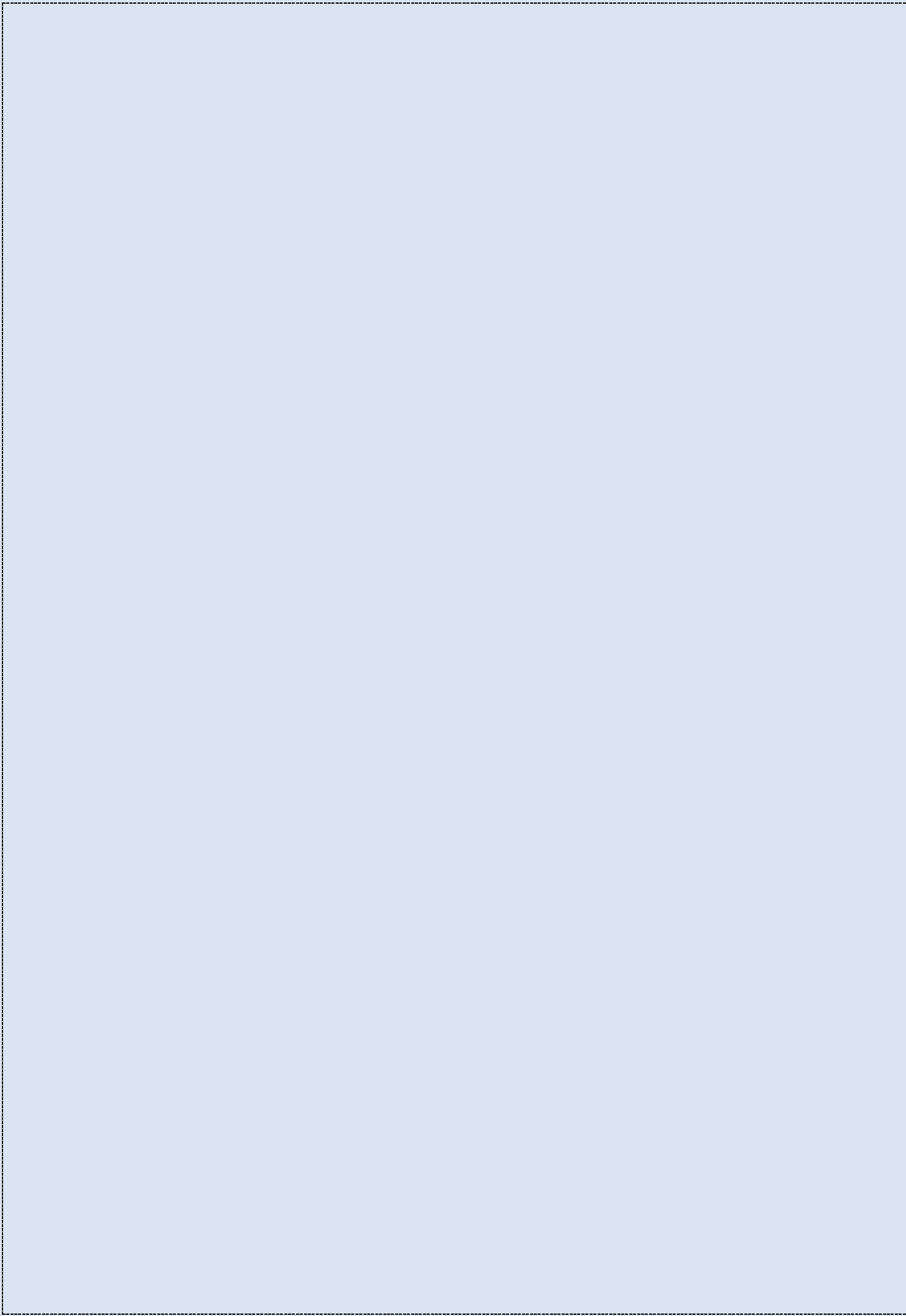
