ORDER:

Section 95 of the Andhra Pradesh Reorganization Act, 2014 (Central Act No.6 of 2014) provides that the existing admission quotas in all Government or private, aided or unaided, institutions of higher and technical education in so far as it is provided under Article 371-D of the Constitution, shall continue as such for a period of ten years from the formation of the State of Telangana during which the existing common admission process shall continue.

2. Now that the period of ten years since formation of Telangana State during which the common admission process was followed has been completed in all Government or Private, Aided or Unaided institutions of Higher and Technical Education, ensuring equal opportunities for quality of Higher Education to all students, in pursuance of section 95, under part XI of the Re-organisation Act, it is proposed to amend the Admission Rules for Under Graduate and Post Graduate Professional courses (Regular / Lateral entry) (Engineering, Technology, Pharmacy, Architecture, Pharm.D, Business Administration, Computer Applications, Law, Education and Physical Education) and Admission Rules, issued in G.Os vide references 1<sup>st</sup> to 10<sup>th</sup> readabove and as subsequently amended from time to time.

3. Government vide G.O. 12<sup>th</sup> read above, have constituted High Level Officers Committee to get comprehensive amendments for reservation in admission in the Educational Institutions in the State. The Committee has since submitted its report and the said report has been approved by the Cabinet Sub-Committee on Reforms in Educational Sector, constituted vide G.O. 11<sup>th</sup> read above.

4. Government after careful examination of the matter, hereby decided to issue amendments to the admission rules of Professional and other courses. Accordingly, the following notification shall be published in the Telangana Gazette, Dated: 27.02.2025:

**NOTIFICATION**

In exercise of the powers conferred by Sections 3 and 15 of the Telangana Educational Institutions (Regulation of Admission and Prohibition of Capitation Fee) Act 1983 (Act No.5 of 1983), the Governor of Telangana hereby makes the following amendments to Admisslons Rules of Under Graduate and Post Graduate professional courses (Regular / Lateral entry) Engineering, Technology, Pharmacy, Architecture,



Pharm.D, Business Administration, Computer Applications, Law, Education and Physical Education, which are issued in the references 1<sup>st</sup> to 10<sup>th</sup> read above:-

- a) At the Rule 7(i)(1) of G.O. 1<sup>st</sup> read above and at Rule 7 of G.O. 2<sup>nd</sup> read above and at Rule 7(i) of G.O's 3<sup>rd</sup> to 9<sup>th</sup> read above and at Rule 8(i) of the G.O. 10<sup>th</sup> read above, in place of "**Region- wise reservation of seats**" the following shall be substituted:-

**"Admission to 85% of the seats** shall be reserved in each course in the Educational Institutions in the **State for the local candidates of O.U. Area** as specified in the Andhra Pradesh Educational Institutions (Regulations and Admissions) Order, 1974 as subsequently amended and the **remaining 15% of the seats shall be un-reserved seats, as follows:**

- (i) All the candidates eligible to be declared as local candidates of O.U. Area.
- (ii) Candidates who have resided in the State for a total period of ten years excluding periods of study outside the State or either of whose parents have resided in the State for a total period of ten years excluding periods of employment outside the State;
- (iii) Candidates who are children of parents who are in the employment of this State or Central Government, Public Sector Corporation, Local Bodies, Universities and other similar quasi Public Institution within the State; and
- (iv) Candidates who are spouses of those in the employment of the State or Central Government Public Sector Corporations, Local Bodies Universities and educational institutions recognized by the Government or a University or Other competent authority and similar other quasi-Government institutions within the State.
